Note: Please note that only those candidates who have registered themselves in the Apprenticeship Portal for Apprenticeship and who fulfil the eligibility criteria as indicated above will be considered for appearing online interview.

Candidates will be called for interview through Google Meet. The date and time of interview will be notified in CSIR-CECRI website and also sent to candidates' Gmail ID.

Interested and eligible candidates should download the requisite application from CECRI website. The application form duly completed in all respect and signed should be sent to **The Administrative Officer, CSIR-Central Electrochemical Research Institute, Karaikudi - 630 003. & reach this office by 31.12.2020 upto 5.30 pm through India post/courier.** Candidates are required to send one set of photocopy of all relevant testimonials with self-attestation as indicated below along with the application-

- (i) Caste/Tribe Certificate [for SC/ST/OBC (Non Creamy Layer)/EWS candidates as applicable] in the prescribed format issued by the Competent Authority as prescribed by Government of India.
- (ii) All Certificates/Testimonials in respect of DOB, qualifications.
- (iii) Experience certificate/Documents issued by the Employer in support of experience
- (iv) Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above within the stipulated period, candidature is liable to be rejected.

I. MINIMUM EDUCATIONAL QUALIFICATIONS:

A. Category – I Trade (ITI) Apprentices: -

Passed out trainees in the particular trade of NCVT pattern designated by Director General of Employment & Training (D.G.E.&T) and who have registered with Regional Directorate of Apprenticeship Training (RDAT), Chennai will only be considered for selection.

B. Category – II Technician (Diploma) Apprentices: -

- A Diploma in Engineering or technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.
- Diploma under recognized Lateral Entry Scheme [(10+2)/ITI admitted in the second year of Diploma course] shall also be considered.

Note:

- ❖ Sandwich diplomas, private diploma, short term/certificate courses etc., are not acceptable.
- ❖ Candidates who have one year or more than one year experience in the relevant field either in Govt. /Public/Private sectors are not eligible.
- ❖ Candidate should not have completed three years after passing of the qualifying examination ie., Candidates who have passed Diploma in/after April 2018 are only eligible to apply.

II. AGE:

Age limit will be followed as per Apprenticeship Rules. The minimum age limit is not less than 14 years.

- SC/ST candidates: 5 years relaxation
- OBC – Non Creamy Layer Candidates: 3 years relaxation
- Persons with disabilities: 10 years relaxation

III. RESERVATION OF VACANCIES:

- ❖ Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD/EWS will be followed. Candidates who are claiming reservation under SC/ST/OBC/PWD/EWS shall provide copy of caste/community certificate (if belongs to SC/ST), Non-Creamy layer certificate (if belongs to OBC), Income & Asset Certificate (if belongs to EWS), Disability certificate (if PWD candidate), failing which their claim for reservation will be considered as 'General' category only.
- ❖ Weightage will be given for PWD/Ex-servicemen, their children & Children of serving armed forces personnel.

IV. DURATION OF TRAINING:

The duration of Apprenticeship training is mentioned in the above Table - A & B.

V. PREVIOUS TRAINING/EXPERIENCE:

Ex-Apprentices or current Apprentices in any organization/firm are not eligible to apply. Combining of apprenticeship with other institutions is not permitted.

VI. APPRENTICESHIP REGISTRATION:

Candidates are advised to register as a Trade/Technician Apprentice online in the following portals under the respective State as per their Trades below:

GENERAL CONDITIONS:

- Candidates should have their valid Aadhar Number.
- The candidates have to submit their **duly filled-in application along with** self-attested copies of certificates, mark sheets, proof of date of birth (copy of SSLC/HSC), Aadhar Card, a passport size photograph.
- Incomplete applications (ie. Non mention of trade for which applied, without photograph, signature and all Semester (ITI & Diploma) Marksheets/Overall Mark sheet of ITI / Consolidated Mark Statement of Diploma and applicable certificates etc.) will not be entertained and will be summarily rejected.
- Candidates should specifically note that the applications received after the closing date for any reason whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by CSIR-CECRI.
- If the candidate does not have a valid gmail id, he/she should create a gmail id before submitting application. Details regarding Interview through Google Meet will be sent to the gmail id only.**
- Eligible/shortlisted candidates shall attend the Online Interview through Google Meet only.
- CSIR-CECRI shall not be responsible if a candidate could not be interviewed online due to connectivity issues/network error / low bandwidth at his/her end.

8. In case of receipt of large number of applications from candidates, the Selection Committee shall adopt its own criteria and shortlist the candidates for online interview in proportionate to the available vacancies.
9. Shortlisted candidates will be provided with Google Meet code 10 minutes prior to interview in their respective Gmail ID. Shortlisted candidates will have to be readily available on the date of interview. (if any change is there, they will be intimated accordingly). In the event of non-response to our Gmail and SMS sharing Gmeet code, the candidate is forfeiting his/her opportunity and thereafter no requests for re-scheduling interview shall be considered.
10. The original documents including educational qualification, Birth/SSLC certificate, community and experience certificate, etc., in respect of selected candidate will be verified at the time of joining. Your joining at CSIR-CECRI as apprenticeship trainee is subject to verification of certificates.
11. Selected Candidate will be provided accommodation in the Institute campus and license fee will be levied.
12. Successful apprenticeship trainees will be awarded National Apprenticeship Certificate by National Council for Vocational Training (NCVT).
13. Any corrigendum/addendum etc. or updates with regard to this advertisement shall be made available on our website: www.cecri.res.in or at (<https://cecri.res.in/Opportunities.aspx>) ONLY.
14. Candidates are advised to periodically visit our website as all future correspondence and latest information with regard to final screening/selection result shall be posted in our website (<https://cecri.res.in/Opportunities.aspx>) and/or by Email/SMS-alerts.
15. The applicant's candidature would be provisional and subject to subsequent verification of certificates and testimonials. 17. Upon completion of the Apprenticeship period CSIR-CECRI shall have NO obligation to offer employment to such apprentices NOR can an Apprentice claim right for employment on the grounds of completion of Apprenticeship.
18. Canvassing in any form and /or bringing in any influence, political or otherwise will be treated as a disqualification.
